Treasurer

State Society is running a surplus. Mr. Schneider suggested investigating a safe investment account for surplus funds.

Motion by Dr. Morock and seconded by Cliff Normand to receive treasurer's report. Motion passed.

Mr. Williams asked about coverage from the new insurance policy. Mr. Schneider answered that chapters and officers are covered by the policy.

Dr. Morock asked about the formation of a finance committee. Members are Mr. McNeely, Mr. Riley, Mr. Vets, and Mr. Rohrbough.

Cheryl Morock reported on the LASSAR Ladies Auxiliary. Their fund raising is to support the youth awards. They will be raffling a 2 night stay at the hotel for the annual meeting. Two colonial flag samplers, cross-stitched by Anne Mitchell, will also be raffled. The ladies auxiliary donated \$2000 to LASSAR in 2017.

Mr. Grace awarded a Martha Washington medal to Katherine Hess for bringing in 5 or more new members to the Ladies Auxiliary. An oak leaf cluster was awarded to Lynda Normand and Karen Vets. Cheryl Morock was awarded 2 oak leaf clusters.

By-Laws Committee

Article II, Section 13 of the by-laws currently states that members accepted in the months of November or December are considered paid for the following year. Mr. Vets reported that according the national by-laws, anyone who was accepted between September-December 2017 will have already paid for 2018. LASSAR could charge state dues separately.

Genealogist

Mr. Jones spoke on the importance of genealogical research for the society. Mr. Francois asked about how much we can expect the applicants to supply to the genealogist. Mr. Jones answered that they should supply as much as possible, at least 2 generations back. The applicant should have the name of the patriot they are working towards. Mr. Williams mentioned that National seems to be making it more difficult for applications to be processed. The society should be a patriotic society based on genealogy, rather than a genealogical society. Mr. Francois suggested that Mr. Vets bring these ideas to the National society. Mr. Vets doubts that the standards will be changed.

Mr. Vets reminded the chapters to submit a DAR Finder Form in appropriate cases.

Southern District

Southern District is composed of Louisiana, Mississippi, Alabama, and Tennessee. New list of approved applications is posted on the website every Thursday. Mr. Vets sends a message to all of those approved members every week. He suggested that chapter presidents and registrars do the same.

Gentlemen,

I had the honor of attending the 128th Congress of the SAR in Houston, Texas, in July, along with three of our fellow compatriots, Tony Vets of the Natchitoches Chapter, and Henry Grace and John McKay of the Gen. Philemon Chapter. The Congress was well attended and many important items were discussed. In addition, new General Officers were elected for the upcoming year. Warren Alter, of Arizona, was elected as the new President General of the SAR.

Among some of the important changes that were discussed and decided on at the Congress included striking the requirement to list the residence of the patriot on new applications, and clarifying some wording regarding memorial, life, and junior memberships. Of particular note, a motion to prevent Past Presidents General, General Officers, and members of the Executive Committee from serving as Trustees, was defeated. President General Larry Guzy attempted to run for President General for a second term, but was prevented from doing so on procedural grounds. Also of note, the winner of the Americanism Poster Contest was none other than Andrew Menard, hosted by the Attakapas Chapter, Louisiana Society SAR. All of our contestants in the youth awards represented Louisiana well.

I will be attending the Fall Leadership and Trustees meeting September 27-29 in Louisville, KY. If there are any particular questions or concerns, please do not hesitate to contact me and I will do what I can to see that those questions are answered and those concerns are addressed. President General Alter was very clear in stating that the Trustees, while tasked with the business of the National Society, are also responsible for communicating concerns from the states to National, and vice versa. As you can imagine, one of the most tasking and critical duties of the State Secretary is the timely production of the Annual Reconciliation. This report is used to determine how much the state owes national for dues and is also how we, both chapter and state, are categorized for award purposes.

I am supplying you with the list of members that your chapter has as of September 15, 2018. I will do my best to keep my copy of this list current as new members are approved. With this in hand there should be NO reason that each chapter cannot have their report to me by January 11th along with ONE (1) check made out to the Louisiana SAR to cover state and national dues. This will give me time to send your chapters check to our State Treasurer and for him in turn to send me our State check made out to the National Society.

Gentlemen, our Annual Reconciliation is due to National by February 1st. I have every intention of ensuring that the Louisiana SAR is in full compliance with this deadline.

Finally, I ask that when you have a change in office that in addition to sending the electronic notice to national (the form is found on www.sar.org) you send me notice as well, especially President and Secretary. This way I can ensure that your new member certificates are delivered correctly and that our website is kept current. Name, address, phone and email address please.

LASSAR Treasurer Summary

September 2018 State Board Meeting Report

<u>Financial Condition of the State Society</u>

The Society is in strong financial condition overall. There was very little financial activity in the first quarter of 2018, but things have picked up since which is reflected in the very "busy" income statement as of 8/31/2018. The only expected large expenditure to come over the next few months is the annual insurance policy payment which will likely be due and paid in September.

Balance Sheet

Cash account balance at 8/31 is right at \$39.5k, up from the 3/31 and 12/31 balances which were right around \$37k. We expect a cash outflow in the fourth quarter for our insurance payment of \$1.5k referenced above. Other than that, the only thing on the Balance Sheet is the life membership totals that we reduce annually which has already been performed for 2018. Those will not be reduced again until 2019.

Income Statement

The revenue lines are self-explanatory.

The special occasions line is the total incurred for the State Society to purchase medals and the \$150 wreath purchase approved earlier this year. The administrative costs total is comprised of \$338.32 in website reimbursement costs and \$570 in registrar, treasurer & secretary expenses. Note registrar, treasurer, and secretary submit expenses a couple of times a year in bulk. The \$500 C.A.R. contribution was approved at previous state board meetings. Oration travel costs came in well below budget. The treasurer expects ending net income to be right around \$3k at 12/31/2018.

2019 Budget

The treasurer has included the 2019 budget for review, consideration, adjustment, and approval. All budget items are recommended to stay in line with 2018 actual results, with the exception of Oration Contest Travel. This amount should likely be increased due to the fact that the 2019 congress is going to take place in California. The treasurer is recommending an increase to a \$3,000 cap.

LASSAR Investment Committee

The treasurer recommends that the society create an investment committee, which would be a separate committee from the finance committee. The reason for the separation is that this is standard practice due to incongruence of a "long term" view an investment committee needs compared to a "current year operating results" attitude that the finance committee should have.

The goal of this committee would be to develop policies & procedures for the society to consider regarding the investment of the society's excess cash balance. This committee would then serve as the decision maker determining which instruments to invest in.

The society typically sees total LASSAR expenses coming in around \$7k-\$8k a year except when "one time" items pop up. Keeping in mind that the society will likely have \$35k in the bank at year end, it appears that cash on hand is approximately 4-5 years' worth of expenses. It is sound practice to have 2 years' worth of expenses in the bank account so that if no income were to be received for 2 years, the society could still function. However, it would be quite prudent to earn a return on all funds in excess of that 2 year threshold.

By simply investing in modest and conservative instruments, income generated could stave off the need for future dues increases as operating costs rise in the future. This would allow any needed dues increases to be brought about at the chapter level, which is where most important activity occurs.

Dues

The Treasurer recommends no increase in State Society dues.







Report of the LA SAR Membership LA SAR Board of Directors Meeting Lafayette, LA September 22, 2018

I am pleased to deliver this report to the Board of Directors, reflecting 2018 year-to-date membership of the state society, as reported to me by our chapter officers. Please refer to the separate spread sheet for details and specific numbers reported to me. Other sources of national data are Jon Toon, NSSAR Registrar, and Tony Vets, LA SAR Secretary.

According to the NSSAR Registrar, Jon Toon, the current 2018 total membership counts are 36,545 (national) and 645 (Louisiana), as of 30 Aug 2018. By way of comparison, the 2017 year's end total counts were 36,961 (national) and 646 (Louisiana). LASSAR REGISTRAR'S REPORT

April 15, 2018 to August 31, 2018

Clifford Normand, Louisiana Society Registrar

General information:

1. There is a problem with contacts from SAR National. Maybe some of these contacts were just curious but either not serious to do the research or not prepared with a clear lineage to a Patriot Ancestor.

2. Memorial applications

At the 128th Congress in Houston, the delegates passed motions dealing with Memorial applications. The first of these was to note that the fee and dues for Memorial memberships would be established by the National Society. The second approved motion was that National Society fees and dues remain the same for 2018-2019 as they were for the previous year, with the exception that the fee and dues for a Memorial application would be the same as for a Regular application. Thus, the cost of a Memorial application is now \$115 (\$80 application fee + \$35 dues), a significant reduction from the previous total cost of \$430. There is no "Family Plan" associated with Memorial applications. Each application "stands alone" and each costs the same amount. Further, there is no distinction between Memorial memberships for Junior (under 18) or Regular (over 18); i.e., all are Memorial members.

- 2) The fee for the engrossed Membership Certificate is included in the national application fees and does not need to be spelled out. The state has not charged nor has provided the rosette for at least the last ten years; therefore, the mention of the fee should be deleted. The LASSAR

application fees since at least 2008 have been \$19 that includes \$12 annual dues and \$7 for postage and other costs.

3) Make the wording for National like the wording for Louisiana Society.

Will the Comite River Diversion Canal disturb the grave site of American Revolution veteran James Penny?

James Penny served as a Private in the 3rd Bn Pennsylvania Militia during the American Revolution and is buried in the Penny-Newport-Nettles Cemetery in East Baton Rouge Parish near the city of Zachary. The cemetery is in a state of disrepair and few people are aware of its existence and the veteran buried there. The cemetery is on property owned by Mr. Adrian Decker and is located in a field next to his residence at 1057 Carney Road.

The concern is that the cemetery is in the area where the Comite River Diversion Canal will cross Old Scenic Highway at Carney Road and Baton Rouge Bayou. A pump station will also be constructed at the location. This could disturb the resting place of James Penny.

THE PENNY-NEWPORT-NETTLES CEMETERY Very Nearly Gone and Pretty Soon Forgotten

It is very hard to believe that this old cemetery has fallen into its present state. It sits on Adrian Decker's place about 14 miles north of Baton Rouge on Carney Road. It would have been trampled by the cows long since except for the fact that Mr. Decker keeps it fenced. It sits under a huge old oak tree (about 16 feet in circumference) named the Henry Watkins Allen Oak. The tree also is in dire need of care.

In 1961 two chapters of the Daughters of the American Revolution restored the cemetery amid much fanfare, but apparently no provision was made for its maintenance. Now forty years later, someone or some organization must undertake this work again if it is to survive.

The James Penny Family

James Penny was born in 1762 in Edinburgh, Scotland, according to family authority. He came to the colonies with his father and fought throughout the Revolution, when he was a mere boy. He came to Louisiana some time around 1785, the year he received Spanish land grants. It seems he acquired additional property, but according to the family, he and his wife, Lucy Kennard, are buried on one of the two original grants.

In 1961 the Long Leaf Pine Chapter, DAR, Shreveport, and the John James Audubon Chapter, Baton Rouge, restored the cemetery and rededicated it in an elaborate ceremony that included the Governor of the State, Jimmy Davis, and the Mayor of Baton Rouge, Jack Christian. They erected tombstones for James and Lucy Penny and, judging from pictures available, did a thorough job of restoring the old cemetery. Their purpose was to honor James Penny, a soldier of the Revolution.

James Penny was married to Lucy Kennard (1769-1839). According to the American State Papers, James received two Spanish land grants in 1785. He would have been twenty-three years old. The history of his plantation, which comprised at least 1120 arpents on the date of his death, will eventually be compiled and available at the Zachary Archives. It should make very interesting reading, since it spans the French government, The British West Florida era, the Spanish era, the Louisiana Purchase, the West Florida Rebellion, and statehood.

The will of James Penny, Sr. is dated May 5, 1834. His exact date of death apparently is not known, but records in the East Baton Rouge Parish Clerk's Office show that it was prior to November 10, 1840. The will was carried into effect on January 18, 1841. Since this will is so unusual, we have included the full text at the end of this article. The will names his surviving children: ELIZABETH STANARD, ROBERT PENNY. ALBERT PENNY, JOSEPH PENNY, NANCY SLOAN, DAVID PENNY AND LUCY SKOLFIELD. There was a son. James, Jr., whose succession proceeding was filed by James Penny, Sr., December 27, 1830, stating that he died "some time in the month of July last". So apparently James, Jr., died away from home. There is no indication that he is buried in this cemetery. There are quite a number of sources available with respect to these children, some of which are listed at the end of this article. Robert Penny was the owner of Highlands Plantation. His family is buried in what is now known as Historic Highland Cemetery.

Upon the death of James, his children by agreement partitioned his property by public auction conducted by Charles Tessier, Parish Judge, on January 18, 1841. The land and a sugar mill were purchased by James Smylie of Smith County, Mississippi. Thus closes the story of James Penny on this land.

The Newport Family

This cemetery is also the burial place of the family of Simpson W. Newport. According to Virginia Jennings, he was a Baptist Minister, married to Susan Kirkendale Young, daughter of Col. Robert Young. Simpson Newport died in 1887, many years after the sale of the land by the Penny children. Further research may reveal the connection of the Newport Family to this cemetery. I have included a chart showing the members of Simpson's family who are buried in this cemetery, as far as we know at present.

Simpson Newport's sister, Eliza Zemina Newport, married Robert T. Young, son of James Young and Judith Coleman. She and her children are buried in the Young Family Cemetery.

We who claim as our goal the preservation of history and genealogy should be able to find some way to restore this old cemetery and maintain it. The task of keeping it fenced has fallen on Mr. Decker. We are indeed fortunate that he has done this.

James Penny was the very epitome of the men who founded this country. He fought for our freedom, and when the fight was won, he came to what must have been a wilderness and established a thriving plantation. He raised a large family, supported his church, and was in all ways an exemplary pioneer and citizen. It seems the least we can do is to preserve his burial place and that of his wife.

I am hoping that by making this situation known, some person or organization will take the initiative and do whatever is necessary to restore and preserve this cemetery, which is quite unique. This probably involves the establishment of a trust, as was done for Historic Highlands Cemetery.

Spanish Militia Units Memorials

Louisiana has very few locations where the patriots who served under the Spanish are able to be recognized. Many of the graves have been lost over the years due to various reasons including river changes, addition of levees along the Mississippi, cemeteries on private properties being lost, families moving away and neglect of family graves.

I would like to propose a program to install a listing of the members of the various militias where we have such records available. This will encourage people visiting their family graveyards to recognize the service of their ancestors in the American Revolution.

I recommend that we set up a committee to include Tony Vets, Jim Morock and myself to look into this program. Attached is a draft of such a memorial for the Iberville Militia that could be installed in the St. Gabriel Church Cemetery. The existing old church dates from 1776.

Silver Good Citizenship Medal Nomination

Colonel Joey Strickland Secretary of the Louisiana Department of Veteran's Affairs

The Pierre Georges Rousseau Chapter nominates Col. Joey Strickland, USA (Ret) for the Silver Good Citizenship Medal for his lifetime accomplishments to veterans across the country.

Col. Strickland was appointed Secretary of the Louisiana Department of Veterans Affairs by Governor John Bel Edwards on Jan. 13, 2016. In this position, he is responsible for overseeing five Veterans Homes, four State Veterans Cemeteries, the department's Parish Service Offices, the Administrative, Contact Assistance, and Claims Divisions, the Military Family Assistance Fund, the Veterans Honor Medal Program, and a myriad of outreach initiatives for Veterans Service Organizations, our homeless, incarcerated, and women Veterans.

As Secretary of Veterans Affairs in Louisiana, Col. Strickland leads 858 employees throughout the state and executes a 71 million dollar budget for the veterans in the State of Louisiana. In 2017 alone, his office ensured that 1.3 billion dollars in VA compensation and pensions were awarded to over 284,000 veterans. A large part of his duties include advocating on behalf of Louisiana's Veterans and their families to the U.S. Department of Veterans Affairs, tasks which he takes on with tenacity and passion. Under his leadership, the Louisiana Department of Veterans Affairs helps veterans understand potential benefits, apply for compensation, pursue denied claims, and ultimately, receive their due honors.

His in-depth knowledge of the Veterans programs comes from his service for more than 15 years as either Director or Deputy Secretary in Louisiana and Arizona's Departments of Veteran's Affairs. In Arizona, Col. Strickland was appointed Director of the Arizona Department of Veterans' Services by Janet Napolitano in July 2008 and served in that capacity until April 2013. Under his leadership there, the Department built a new veterans home in Tucson and renovated another one in Phoenix. He also served as National Troops to Teachers Director for Native Americans.

At the national level, Secretary Strickland served as Chairman of the Veterans Affairs Advisory Committee for Minority Veterans and as President of the National Association of State Directors of Veterans Affairs (NASDVA) from 2003-2004. As NASDVA President, he testified on behalf of Veterans issues before the U.S. Congress.

Before his service with the Veterans Administration offices in Arizona and Louisiana, Secretary Strickland served 29 years in the U.S. Army, including two tours of duty in Vietnam. In 1994, he retired as a Lieutenant Colonel and was later appointed Colonel in the Louisiana State Guard by Governor Mike Foster, while serving on the Governor's Military Advisory Board. His awards include the Legion of Merit, Meritorious Service Medal with 4 Bronze Oak Leaf Clusters, Army Commendation Medal (2nd award), Air Medal (3rd award), Republic of Vietnam Campaign Medal, Vietnam Service Medal with 7 battle stars, Airborne Medal, Overseas Ribbon, among others.

Colonel Strickland's many accomplishments over his service career is a testament to his outstanding character and patriotism. It is with great pride and pleasure that the Pierre Georges Rousseau Chapter nominates Colonel Strickland to receive the Silver Good Citizenship Medal.
